Article I (Objective)

To ensure the proper operation of the university and to regulate the rights and obligations of faculty, staff, and students, as specified by Article 36 of the *University Act*, the university has established the *Taipei Medical University Organization Regulations* (hereinafter referred to as the "Regulations").

Article II (The University's Purpose)

The university aims to cultivate medical and biotechnology professionals with a strong sense of humanistic care, innovative capabilities, and a global perspective, who will contribute to medicine and healthcare, advance life sciences research, and serve society as a whole.

Article III (The Appointment, Term, and Reappointment of the President)

The university appoints one (1) President to oversee its administrative affairs. The selection process begins with a nomination committee organized by the Board of Trustees, which selects two to three candidates. These nominees are then submitted to the Board of Trustees for a final vote and subsequently reported to the Ministry of Education for approval,

after which the appointment becomes effective. Each term lasts three years, with the eligibility to be re-appointed once. Within three months after the end of each academic year, a performance report prepared in alignment with the university's governing principles shall be submitted to the Board of Trustees for evaluation. One year before the expiration of each President's term, the Board of Trustees shall evaluate whether the President is eligible for reappointment. If the President is not reappointed or if the position becomes vacant for any reason, the Board of Trustees shall form a nomination committee within one month and carry out all necessary procedures for the selection of a new university President in accordance with relevant regulations. In the event where the President is unable to fulfill their duties for any reason or if the selection process for a new President has not been completed, the Board of Trustees shall appoint a Vice President to serve as acting President and report this to the Ministry of Education.

Article IV (Vice President Number, Qualifications, and Term)

The university may appoint up to five (5) Vice Presidents to assist the President in managing administrative affairs. Vice Presidents are appointed directly by the President from among the faculty or, alternatively, an external candidate (at most one) may be appointed on a contractual basis. The term of each Vice President shall align with the President's term.

Article VI (Board of Trustees Staff)

The university appoints one (1) secretary to the Board of Trustees, who may either be a teaching faculty member at the rank of lecturer or higher serving in a part-time capacity, or a full-time staff member. Additional personnel will be appointed to handle daily administrative tasks and keep meeting minutes.

Article VII (Administrative Units)

The university has established the following administrative units:

1. Office of President: Under which the Auditing Section reports directly.
2. Office of Academic Affairs: Under which the Admission Section, Registration Section, Curriculum Section, Center for Teaching Resources, Center for Faculty Development, Center for Education in Medical Simulation (CEMS), and Bilingual Education Promotion Center report directly.

3. Office of Student Affairs: Under which the Life Guidance Section, Extracurricular Activities Section, Career Planning and Placement Section, Student Counseling Center, Service Learning Center, and the Military Education Section report directly.
4. Office of General Affairs: Under which the General Services Section, Cashier Section, Property Management Section, and Construction and Maintenance Section report directly.
5. Office of Research and Development: Under which the Research Promotion Center, Core Facility Center, and Laboratory Animal Center report directly.
6. Office of Information Technology: Under which the Internet Communication Section, System Development Section, Information Support Section, Cybersecurity Section, and Center for Multi-Metaverse Media Section report directly.
7. Office of Global Engagement: Under which the Global Partnerships Section, International Students Section, International Research Section, and Global Initiatives Section report directly.
8. Office of Continuing & Extension Education: Under which the Continuing Education Section and Promotion Service Section report directly.
9. Library: Under which the Reader Services Section, Technical Services Section, and Knowledge Services Section report directly.
10. Office of Secretariat: Under which the University Planning Section, Secretariat Affairs Section, Public Relation & Publishing Section, and the University Archives report directly.
11. Office of Human Resources: Under which the Human Resource Service Section and Human Resource Development Section report directly.
12. Office of Finance: Under which the Accounting Section and Financial Planning Section report directly.
13. Office of Environmental Protection and Occupational Safety: Under which the Occupational Safety Section and Health Section report

directly.

14. Office of Physical Education Affairs: Under which the Teaching & Facilities Section and Health & Sports Section report directly.

19. Office of Legal Affairs: Under which the Legal Section and Legal Compliance Section report directly.
20. Office of Data Science: Under which the Clinical Data Center, Health Data Analytics and Statistics Center, Institutional Research Center, and Bioinformatics Center report directly.
21. Office of Sustainable Development: Under which the Social Innovation Section and Sustainable Environment Section report directly.

Article VIII (Other Centers and Units)

The university may establish various centers and other units to support teaching, research, administrative functions, and outreach services.

The President shall appoint faculty members at the rank of Associate Professor or above to serve part-time as heads of the aforementioned centers and units, or designate full-time staff for these roles. The regulations for the establishment and operation of each center and unit shall be prescribed

otherwise.

Article IX (Affiliated Institute and Related Businesses)

The university may establish affiliated institutions to meet the needs of teaching, medical services, long-term care services, and biotechnology development. It may also accept commissioned institutions for medical services and long-term care as affiliated institutions. Alternatively, such relationships may be formed through investments or other lawful means, including commissions from government agencies, private enterprises, or individuals, to manage related operations. The organizational regulations for these institutions shall be prescribed elsewhere and the implementation shall follow their passage by the University Affairs Council and subsequent approval by the Board of Trustees.

Article X (Center for Management and Development)

The President shall appoint one (1) Director to the Center for Management and Development, who may be a faculty member at the rank of Associate Professor or above serving part-time or a full-time staff member. The President shall appoint one (1) Deputy Director for each Division, who may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members.

Article X-I (Office of Business Development)

The President shall appoint one (1) Dean to the Office of Business Development, who may be a faculty member at the rank of Associate Professor or above serving part-time or a full-time staff member. The President shall appoint one (1) Director for each Division, who may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members.

Article XI (Office of Human Research)

The President shall appoint one (1) Dean to the Office of Human Research, who may be a faculty member at the rank of Associate Professor or above serving part-time or a full-time staff member. The President shall appoint one (1) Director for each Department, Center, and the Joint Biobank, who may be faculty members at the rank of Assistant Professor or above serving part-time or full-time staff members, along with an appropriate number of additional staff members.

Article XII (Office of Academic Affairs)

The President shall appoint one (1) Dean to the Office of Academic Affairs, who is a faculty member at the rank of Professor serving part-time, to oversee all academic affairs of the university. The President shall appoint one (1) Director for each Center and one (1) Section Chief for each Section, who may be faculty members at the rank of Assistant Professor or above serving part-time, or full-time staff members, along with an appropriate number of additional staff members.

Article XII-I (Office of Sustainable Development)

The President shall appoint one (1) Chief Sustainability Officer to the Office of Sustainable Development, who may be a faculty member at the rank of Associate Professor or above serving part-time or a full-time staff member. The President shall appoint one (1) Section Chief for each Section, who may be faculty members at the rank of Assistant Professor or above serving part-time, or full-time staff members, along with an appropriate number of additional staff members.

Article XIII (Office of Student Affairs)

The President shall appoint one (1) Dean to the Office of Student Affairs, who is a faculty member at the rank of Professor serving part-time, to oversee all student affairs of the university. The President shall appoint one (1) Director for each Section or Center, who may be faculty members at the rank of Assistant Professor or above serving part-time, or full-time staff members, along with an appropriate number of additional staff members.

Article XIV (Military Education Section)

The President shall appoint one (1) Director to the Military Education Section, either from personnel deemed suitable by the President or selected from two to three military training instructors recommended by the Ministry of Education; while an appropriate number of military training instructors shall be appointed to handle the planning and teaching of the military education curriculum.

Article XV (Office of Physical Education Affairs)

The President shall appoint one (1) Dean to the Office of Physical Education Affairs, who is a faculty member at the rank of Associate Professor or above serving part-time, or full-time staff members, to oversee all physical education affairs and matters related to health promotion in the university. The President shall appoint one (1) Section Chief for each Section, who may be faculty members at the rank of Assistant Professor or above serving part-time, or full-time staff members, along with an appropriate number of additional staff members.

Article XVI (Office of General Affairs)

The President shall appoint one (1) Dean to the Office of General Affairs, who is a faculty member at the rank of Associate Professor or above serving part-time, or full-time staff members, to oversee all general affairs of the university. The President shall appoint one (1) Section Chief for each Section, who may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members.

Article XVII (Office of Research and Development)

The President shall appoint one (1) Dean to the Office of Research and Development, who is a faculty member at the rank of Professor serving part-time to oversee matters related to research and development in the university. The President shall appoint one (1) Director for each Center, who

may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members.

Article XVIII (Office of Information Technology)

The President shall appoint one (1) Chief Information Officer (CIO) to the Office of Information Technology, who is a faculty member at the rank of Associate Professor or above serving part-time, or a full-time staff member, to oversee matters related to information services in the university. The President shall appoint one (1) Director for each Center and one (1) Section Chief for each Section, who may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members.

Article XVIII-I (Office of Data Science)

The President shall appoint one (1) Chief Data Officer to the Office of Data Science, who is a faculty member at the rank of Associate Professor or above serving part-time, or a full-time staff member, to oversee matters related to data science services in the university. The President shall appoint one (1) Chief for each Center, who may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members.

Article XIX (Office of Global Engagement)

The President shall appoint one (1) Dean to the Office of Global Engagement, who is a faculty member at the rank of Associate Professor or above serving part-time, or a full-time staff member, to oversee matters related to global and cross-strait academic exchange and collaboration, international student recruitment and support, and the promotion of the university's global visibility of the university. The President shall appoint one (1) Chief for each Section, who may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members.

Article XX (Office of Continuing & Extension Education)

The President shall appoint one (1) Dean to the Office of Continuing & Extension Education, who is a faculty member at the rank of Associate Professor or above serving part-time, or a full-time staff member, to oversee matters related to continuing education promotion of the university. The President shall appoint one (1) Section Manager for each Section, who may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members.

Article XXI (Library)

The President shall appoint one (1) Director to the Library, who is a faculty member at the rank of Associate Professor or above serving part-time, or a full-time staff member. The President shall appoint one (1) Section Chief for each Section, who may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members.

Article XXII (Office of Secretariat)

The President shall appoint one (1) Chief Secretary to the Office of Secretariat, who is a faculty member at the rank of Associate Professor or above serving part-time, or a full-time staff member. The President shall appoint one (1) Section Chief for each Section and one (1) Director for the University Archives, who may be faculty members at the rank of Assistant Professor or above serving part-time or full-time staff members, along with an appropriate number of additional staff members.

Article XXII-I (Office of Public Affairs)

The President shall appoint one (1) Dean to the Office of Public Affairs, who is a faculty member at the rank of Associate Professor or above serving part-time, or a full-time staff member. The President shall appoint one (1) Section Director for each Section, who may be a faculty member at the rank

of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members.

Article XXII-II (Office of Legal Affairs)

The President shall appoint one (1) Vice President for Legal Affairs to the Office of Legal Affairs, who is a faculty member at the rank of Associate Professor or above serving part-time, or a full-time staff member. The President shall appoint one (1) Division Director for each Section, who may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members.

Article XXII-III (Auditing Section)

The President shall appoint one (1) Director to the Auditing Section under the Office of President, who may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members.

Article XXIII (Office of Finance)

The President shall appoint one (1) Chief Financial Officer to the Office of Finance, who is a faculty member at the rank of Associate Professor or above serving part-time, or a full-time staff member. The President shall appoint one (1) Section Chief for each Section, who may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members, to manage annual budgeting, accounting, and statistical matters in accordance with the law.

Article XXIV (Office of Human Resources)

The President shall appoint one (1) Dean to the Office of Human Resources, who is a faculty member at the rank of Associate Professor or above serving part-time, or a full-time staff member. The President shall appoint one (1) Section Chief for each Section, who may be a faculty member at the rank of

Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members, to manage human resource matters in accordance with the law.

Article XXV (Office of Environmental Protection and Occupational Safety)

The President shall appoint one (1) Dean to the Office of Environmental Protection and Occupational Safety, who is a faculty member at the rank of Associate Professor or above serving part-time, or a full-time staff member. The President shall appoint one (1) Section Chief for each Section, who may be a faculty member at the rank of Assistant Professor or above serving part-time or a full-time staff member, along with an appropriate number of additional staff members, to manage environmental protection and occupational safety matters in accordance with the law.

Article XXVI (Establishment of Branches)

The university may establish branches outside the Taipei campus as needed for development. The President shall appoint one (1) Director to the branch who is a faculty member at the rank of Professor or above, to oversee the university's administrative matters in the branch.

Article XXVII (Selection and Appointment of the College Deans)

One (1) Dean for each College shall be appointed, along with an appropriate number of additional staff members.

The selection process of the College Dean begins with a nomination committee organized by the President, who selects two to three Professors as candidates. These nominations are then submitted to the President for a final selection, after which the appointment becomes effective. However, the first Dean shall be directly appointed by the President.

Each term for College Deans lasts three years, with the eligibility to be reappointed once.

An Evaluation Committee shall be formed by the President to assess the qualifications of candidates for the reappointment of the aforementioned

College Dean.

Within three months after the end of each academic year, the College Dean shall submit a college affairs development report, which will be evaluated by an Evaluation Committee formed by the President. If the evaluation determines that the Dean is inadequate for the position, they may be dismissed.

The procedural guidelines for the College Dean's selection, reappointment evaluation, annual assessment, and dismissal shall be prescribed elsewhere.

Article XXVIII (The Selection Appointment of the Directors of Schools or Institutes)

One (1) Director shall be appointed for each School or Institute to oversee all matters related to its operations.

The selection process of the School or Institute Director begins with a nomination committee organized by the President to select two to three candidates, who are at the rank of Associate Professors or above. These nominations are then submitted to the President for a final selection, after which the appointment becomes effective.

Each term for School or Institute Director lasts three years, with the eligibility to be reappointed once.

An Evaluation Committee shall be formed by the President to assess the qualifications of candidates for the reappointment of the aforementioned School or Institute Director .

Within three months after the end of each academic year, the School or Institute Director shall submit a school (or institute) affairs development report, which will be evaluated by an Evaluation Committee formed by the President. If the evaluation determines that the Dean is inadequate for the position, they may be dismissed.

For Departments within the Schools, the Department Director shall recommend one to two candidates at the rank of Assistant Professor or above each academic year. These recommendations are reviewed and

selected by the Dean and then submitted to the President for approval before the appointment becomes effective.

The procedural guidelines for the School or Institute Director's selection, reappointment evaluation, annual assessment, and dismissal shall be prescribed elsewhere.

Article XXIX (The Selection and Appointment of Degree Program Directors)

One (1) Director shall be appointed for each Degree Program. The Dean shall recommend candidates, and the President shall appoint one from among faculty members at the rank of Associate Professor or above to serve part-time. Each term for Degree Program Director lasts three years, with the eligibility to be reappointed once. Reappointment shall be carried out by the President following the completion of the consultation process. The Degree Program Director may be relieved of their duties by the President before the end of their term in the event of significant circumstances.

Article XXIX-I (The Selection and Appointment of the Center for General Education Director)

The university has established the Center for General Education to plan and promote the development of general education. The President shall appoint one (1) Director to the Center for General Education, who is a faculty member at the rank of Associate Professor or above serving part-time. The President shall appoint one (1) Section or Center Director for each Section, Language Center, and Center for Arts and Humanities, who may be a faculty member at the rank of Assistant Professor.

Article XXX (The Selection and Appointment of the Superintendent of the Affiliated Hospitals)

The President shall appoint one (1) Superintendent to the affiliated hospitals, who is a tenure-track professor with clinical medical doctors' qualifications (including dentists). The nomination shall be submitted to the Board of Trustees for approval, after which the appointment becomes effective.

Article XXX-I (The Selection and Appointment of the Directors of Affiliated Institutes)

In addition to the affiliated hospitals mentioned in the previous article, the President shall appoint one (1) Director or Person-in-Charge for each of the university's other affiliated institutions. The appointee may be a full-time faculty member at the rank of Associate Professor or above, or a staff member with appropriate clinical medical professional qualifications. The nomination shall be submitted to the Board of Trustees for approval, after which the appointment becomes effective.

Article XXXI (The Term of Unit Directors or Chiefs)

The Directors or Chiefs listed in Articles 8, 10 to 26, and 29-1 shall be appointed by the President each academic year. The maximum duration for consecutive reappointments is six (6) years. For teaching faculty serving part-time in these roles, the term of their part-time positions shall comply with the university's regulations on faculty appointments.

Article XXXII (Teachers, Professional Technicians, and Researchers)

The university's faculty consists of four ranks: Professors, Associate Professors, Assistant Professors, and Lecturers. Faculty appointments at each rank shall be made by the President upon approval by the Department-level (limited to the School of Medicine), College-level, and University-level Teacher Evaluation Committees. Professional technicians may be recruited and appointed to assist with teaching duties. To enhance the quality of teaching and research, Honorary Professors and Chair Professors may be appointed. The guidelines for these appointments shall be prescribed elsewhere, and their implementation shall be subject to approval by the Board of Trustees. Visiting Professors may also be appointed, with guidelines prescribed elsewhere and implemented upon approval by the University Affairs Council.

The university may recruit and appoint researchers to engage in research activities. Researchers consist of three ranks: Researchers, Associate Researchers, and Assistant Researchers. The appointment of Researchers

shall be prescribed elsewhere.

Article XXXIII (The Selection and Appointment of the Deputy Directors of Units)

Each academic and administrative unit may appoint one (1) to five (5) Deputy Directors based on the needs of university development when the scale or workload becomes substantial. The detailed guidelines for such appointments shall be prescribed elsewhere.

Article XXXIV (University Affairs Council)

The university shall establish the University Affairs Council, which is composed of the President, Vice President, the Dean of Academic Affairs, Dean of Student Affairs, Dean of General Affairs, Dean of Research and Development, Chief Information Officer, Dean of Global Engagement, Dean of Center for General Education, Director of Continuing and Extension Education, Deans of each College, Directors of each School and Institute, Directors of each Degree Program, Superintendents of each affiliated hospital, Director of Center for Management and Development, Dean of Business Development, Library Director, Chief Secretary, Dean of Public Affairs, Dean of Human Resource, Chief Financial Officer, Dean of Environmental Protection and Occupational Safety, Dean of Physical Education Affairs, Dean of Human Research, Vice President for Legal Affairs, Director of Military Education Section, Chief Data Officer, Faculty Representative, Researcher Representative, Staff Representative, and Student Organization Representatives.

Faculty Representatives shall be elected from among the university's tenure-track faculty members. The number of Faculty Representatives must not be less than half of the total members of the University Affairs Council. Among the Faculty Representatives, those holding the rank of Professor or Associate Professor must constitute no less than two-thirds of the total Faculty Representatives. The number of Faculty Representatives from any single School shall not exceed half of the total Faculty Representatives.

One (1) Researcher Representative shall be elected from among all

university researchers to attend. Ten (10) Staff Representatives shall be elected from among all university staff members to attend.

The number of Student Representatives shall be no less than one-tenth of the total members of the University Affairs Council. The Student Association and the Student Representative Council shall each appoint two individuals as ex officio representatives, while the remaining Student Representatives shall be elected by the students of each department.

For calculations under Items 2 and 4, the rounding-up method shall be applied for non-integer values.

The President or proposing unit(s) may invite other relevant personnel to attend the Council meeting when necessary.

The term of a University Affairs Council Representative is one year. Representatives shall lose their eligibility if they no longer hold their original position or are unable to attend meetings for more than six (6) consecutive months due to other reasons. In such cases, replacements shall be appointed.

The President shall convene the University Affairs Council meetings at least once each academic semester. If the President is unable to preside over the meeting, a designated representative shall act on their behalf. If one-fifth or more of the University Affairs Council Representatives request an extraordinary meeting, the President shall convene it within fifteen (15) days. The University Affairs Council meeting minutes shall be submitted to and archived by the Board of Trustees. Committees of various purposes or project-based teams may be established to address matters delegated by the University Affairs Council when necessary.

Article XXXV (University Affairs Council Matters of Deliberation)

The following matters shall be subject to deliberation by the University Affairs Council:

1. University development plans and budgets.

2. Organization regulations and other important regulations and guidelines.
3. The establishment, alternation, adjustment, and cancellation of Colleges, Schools, Institutes, Degree Programs, and affiliated institutes.
4. Academic affairs, student affairs, general affairs, and other important matters.
5. The discussion and formulation of matters related to teaching evaluation methods.
6. Resolutions made by the committees or project-based teams established by the University Affairs Council.
7. Meeting proposals and matters proposed by the President.
8. Other significant matters related to university affairs.

Article XXXVI (Other Meetings)

The university will establish the following meetings:

1. **Administrative Affairs Committee Meeting:** Composed of the President, Vice Presidents, Director of first and second tier academic and administrative units, the affiliated hospital superintendents, and an appropriate number of elected Student Representatives. The President shall serve as the chair to lead discussions on significant administrative affairs of the university.
2. **Academic Affairs Faculty Meeting:** Composed of the Dean of Academic Affairs, Deans of each College, Dean of Global Engagement, Dean of Center for General Education, Directors of each School and Institute, Director of each Degree Program, Associate Superintendent at affiliated hospitals, the Library Director, and an appropriate number of elected Student Representatives. The Dean of Academic Affairs shall serve as the chair to lead discussions on significant academic affairs of the university.
3. **Student Affairs Committee Meeting:** Composed of the Dean of Student

Affairs, Deans of each College, Dean of Global Engagement, Faculty Representatives, and an appropriate number of elected Student Representatives. Relevant mentors and students may be invited to attend the meeting when necessary. The Dean of Student Affairs shall serve as the chair to lead discussions on significant student affairs and review the regulations of student affairs.

4. General Affairs Committee Meeting: Composed of the Dean of General Affairs, Chiefs of each Section, Faculty Representative, and an appropriate number of elected Student Representatives. Relevant personnel may be invited to attend the meeting when necessary. The Dean of General Affairs shall serve as the chair to lead discussions on significant general affairs.
5. Research and Development Committee Meeting: Composed of the Dean of Research and Development, Associate Dean of Research and Development, Directors of each Center, Dean of Human Research, Dean of Business Development, and Deans of each College, and an appropriate number of professor representatives. The Dean of Research and Development shall serve as the chair to lead discussions on significant matters of research and development in the university.
6. Information Technology Meeting: Composed of the Chief Information Officer, Section Chiefs of each Section, Faculty Representative, and an appropriate number of elected Student Representatives. Relevant personnel may be invited to attend the meeting when necessary. The Chief Information Officer shall serve as the chair to lead discussions on significant matters of information technology.
7. Global Engagement Committee Meeting: Composed of the Dean of Global Engagement, Vice Dean of Global Engagement, Deans of each College, Dean of Academic Affairs, Dean of Student Affairs, Dean of Research and Development, and professor representatives. The Dean of Global Engagement shall serve as the chair to lead discussions on

matters related to the university's international and cross-strait academic exchange and collaboration, as well as other important issues such as international student recruitment and support.

8. Faculty Meeting of the College: Composed of the Deans of each College; Directors of each College, School, Institute, Degree Program, and Center; Faculty Representatives; and an appropriate number of elected Student Representatives. The College Dean shall serve as the chair to lead discussions on significant matters of the college.
9. Center for General Education Meeting: Composed of the Chief Information Officer, Section Chiefs of each Section, Faculty Representative, and an appropriate number of elected Student Representatives. The Director Center for General Education shall serve as the chair to lead discussions on significant matters about general education.
10. SDT Affairs Committee Meeting of Each School: Composed of the Dean, professors, associate professors, assistant professors, lectures, and an appropriate number of elected Student Representatives of each School. Military education instructor and mentors may be invited to attend the meeting when necessary. The Deans shall serve as the chair to lead discussions on relevant matters of each School.
11. Institute Affairs Committee Meeting for Each Institute: Composed of the Director, professors, associate professors, assistant professors, lectures, and an appropriate number of elected Student Representatives of each Institute. The Director shall serve as the chair to lead discussions on relevant matters of each Institute.
12. Budget Committee Meeting: Composed of the President, Vice Presidents, Chief Secretary, superintendents of affiliated hospitals, Deans of each college, Director of the Center for General Education, first-tier Directors of each administrative unit, Chair of the Welfare Committee, two (2) to three (3) Faculty Representatives (who are non-

administrative directors) appointed by the President, the Student Association Lead, and the Chair of the Student Representative Council. The President shall serve as the chair to lead discussions on matters of budget planning.

13. Physical Education Affairs Committee Meeting: Composed of the Dean of Physical Education Affairs, Section Chief of each Section, Faculty Representatives, and an appropriate number of elected Student Representatives. Relevant personnel may be invited to attend the meeting when necessary. The Dean of Physical Education Affairs shall serve as the chair to lead discussions on the university's physical education affairs and matters related to health promotion.
14. Management and Development Committee Meeting: Composed of the President, Vice President, Chief Secretary, superintendents at affiliated hospitals, and the Director of Center for Management and Development. The President shall serve as the chair. Relevant personnel may be invited to attend the meeting when necessary.

Article XXXVII (Student Association)

The university has established the Student Association, a self-governing student organization, to address matters related to students' learning, campus life, and rights, ensuring the protection of their interests. The organizational charter, along with regulations concerning the selection of Student Representatives, and meetings related to academics, campus life, as well as the establishment of awards and disciplinary rules, shall be prescribed elsewhere.

Article XXXVIII (University-Level Teacher Evaluation Committee)

The university has established the University-level Teacher Evaluation Committee, consisting of thirty-nine (39) to forty-nine (49) members. The President, Vice Presidents, superintendents of affiliated hospitals, Dean of Academic Affairs, Dean of Research and Development, Deans of each College, and the Director of the Center for General Education serve as ex

officio members. The remaining members are elected, with the President serving as the Chair of the Committee.

The number of elected members on the University-level Teacher Evaluation Committee shall not be fewer than the number of ex officio members. Members of each gender must comprise at least one-third of the total committee membership.

The University-level Teacher Evaluation Committee shall review matters related to faculty appointments, contract terms, promotions, suspension of employment, non-renewal of contracts, determination of reasons for termination, dismissals, and other matters requiring review by the Committee in accordance with relevant laws and regulations.

The Teacher Evaluation Committee follows a two-tier review system, including the College-level and University-level committees; while the School of Medicine adopts a three-tier review system, comprising the Department-level, College-level, and University-level committees. The regulations for the establishment and operation of Teacher Evaluation Committees at each level shall be prescribed elsewhere. The regulations for the establishment and operation of the University-level Teacher Evaluation Committees shall pass the review by the University Affairs Council.

Article XXXIX (Teacher Appeals Review Committee)

The university has established the Faculty Appeals Review Committee, consisting of fifteen (15) to twenty-one (21) members. The committee is composed of ten (10) to sixteen (16) Tenure-Track faculty members at the rank of Associate Professor or above, one (1) scholar or expert, one (1) impartial public representative, one (1) legal professional, one (1) university representative, and one (1) representative from a teachers' organization of Taipei City. Among the members, the number of non-administrative faculty members shall constitute no less than two-thirds of the total committee membership. Members of each gender must comprise at least one-third of the total committee membership.

Members of the University-level Teacher Evaluation Committee shall not concurrently serve as members of the Faculty Appeals Review Committee.

The President shall convene the Faculty Appeals Review Committee, while the chair shall be elected by the committee members from among themselves. The Faculty Appeals Review Committee is responsible for reviewing appeal cases involving university faculty and military education instructors. The organization, requirements for appeals, and procedural guidelines of the Committee shall be prescribed elsewhere and implemented following approval by the University Affairs Council.

Article XL (Staff Appeals Review Committee)

The university has established the Staff Appeals Review Committee, consisting of nine (9) members. The Vice President shall serve as an ex officio member and convener. The other members shall include five (5) faculty or staff members who do not hold administrative positions, one (1) legal professional, and two (2) impartial public representatives. Members of each gender must comprise at least one-third of the total committee membership. The chair of the Staff Appeals Review Committee shall be elected by the committee members from among themselves.

The Staff Appeals Review Committee is responsible for reviewing appeals from university staff regarding dismissals, suspensions, performance evaluations, and other disciplinary actions. The organization, requirements for appeals, and procedural guidelines of the Committee shall be prescribed elsewhere, reviewed by the University Affairs Council, and implemented upon approval by the Board of Trustees.

Article XLI (Student Appeals Committee)

The university has established the Student Appeals Committee, consisting of seventeen (17) to nineteen (19) members. The Chief Secretary shall serve as an ex officio member and convener. The other members shall include ten (10) to twelve (12) faculty members selected by the President, one (1) to two (2) legal professional(s), one (1) scholar, one (1) representative from a

teacher's organization of Taipei City, and two (2) Student Representative. Among the members, the number of non-administrative faculty members shall constitute no less than a half of the total committee membership. Members of each gender must comprise at least one-third of the total committee membership. The chair of the Student Appeals Committee shall be elected by the committee members from among themselves. Members of the Student Awards and Disciplinary Committee shall not concurrently serve as members of the Student Appeals Committee.

The Student Appeals Committee is responsible for reviewing appeals submitted by students, Student Association, and other relevant self-governing organizations. The organization, requirements for appeals, and procedural guidelines of the Committee shall be prescribed elsewhere, reviewed by the University Affairs Council, and implemented upon approval by the Ministry of Education.

Article XLII (Other Committees)

The university has established the following committees:

1. Admissions Committee: Responsible for overseeing all admission-related matters of the university (excluding international students).
2. Teaching Evaluation Committee: Responsible for planning and conducting teaching evaluations and providing recommendations for teaching improvements.
3. Curriculum Committee: Responsible for coordinating matters related to the review and approval of core required courses, electives, and shared required courses, as well as credit allocation, curriculum reform, and evaluation for all schools and colleges within the university.
4. Procurement Committee: Responsible for planning and executing the university's procurement processes, including the review and bidding of construction and renovation projects.
5. Welfare Committee: Responsible for overseeing the planning,

- coordination, and implementation of all staff welfare-related matters.
6. Library Committee: Responsible for planning and advancing library operations and development, as well as deciding on budget allocation and book procurement.
 7. Radiation Protection Management Committee: Responsible for managing the university's ionizing radiation materials and equipment, preventing hazards and contamination from ionizing radiation, and ensuring the health and safety of all university personnel.
 8. Occupational Safety and Health Committee: Responsible for planning, promoting, and monitoring matters related to workplace safety and health.
 9. Human Resource Planning and Review Committee: Responsible for planning, reviewing the human resource-related matters in the university and affiliated institutes. According to the Gender Equity Education Act, members of any gender must constitute at least one-third of the total membership of each committee.
 10. Fundraising Committee: Responsible for raising funds for university development, as well as planning, executing, and reviewing fundraising activities.
 11. Continuing and Extension Education Review Committee: Responsible for reviewing admission-related matters for each cohort in the continuing and extension education programs.
 12. University Health Committee: Responsible for promoting health education within the university, improving environmental sanitation, and safeguarding the health of students, faculty, and staff.
 13. Gender Equity Education Committee: Responsible for promoting gender equity, safeguarding the rights of students, faculty, and staff, and ensuring a safe educational environment.
 14. Joint Committee for Ethics of Human Trial: Responsible for planning

and reviewing human research trials conducted by the university and its affiliated institutions to ensure the protection of participants' rights.

15. Academic Ethics Advisory Committee: Responsible for overseeing academic ethics management, education, and the review of academic ethics cases.
16. Toxic Chemical Substances Management Committee: Responsible for managing and monitoring toxic chemical substances and addressing concerns related to chemical substances.
17. Biosafety Committee: Responsible for managing hazardous microorganisms or biological toxins classified as tier-two or higher and promoting efforts related to biosafety in biological experiments.
18. Faculty Development Committee: Responsible for planning activities related to faculty career development in teaching, research, and service.
19. Information Security Committee: Responsible for formulating the university's information security policies.
20. Business Development Committee: Responsible for formulating and reviewing strategies and plans for auxiliary business development, as well as evaluating and overseeing the operational objectives and performance of these businesses.
21. Joint Human Biobank Ethics Committee: Responsible for reviewing and overseeing matters related to the management of biobanks at the university and its affiliated institutions.
22. Institutional Animal Care and Use Committee: Responsible for reviewing, monitoring, and managing animal research projects, as well as overseeing the animal facility's housing environment and ensuring humane care and ethical management.
23. Joint Procurement Committee: Responsible for planning and executing the procurement processes of the university's affiliated institutes, including the review and bidding of construction and renovation

projects.

24. Human Trials Board: Responsible for formulating policies related to human trial research at the university and its affiliated hospitals, as well as evaluating their implementation performance.
25. University Affairs Development Committee: Responsible for formulating medium-term and long-term university development proposals, planning major campus projects, and reviewing significant investments and financial matters.
26. Self-Evaluation Advisory Committee: Responsible for reviewing and approving self-evaluation policies, guidelines, and implementation plans, evaluation results, improvement strategies proposed by the evaluated units, and determining whether the improvement outcomes warrant closure or require continued follow-up.
27. Publication Committee: Responsible for enhancing the university's publishing capacity, encouraging the publication of high-quality academic and teaching works, promoting academic research development, and improving the university's overall image.
28. General Education Committee: Responsible for formulating the direction and policies for general education development, planning general education courses, and reviewing major general education initiatives.
29. Internal Control Committee: Responsible for reviewing and planning the university's internal control system, evaluating risk assessments from various units, and providing recommendations.
30. International Student Admissions and Scholarship Review Committee: Responsible for coordinating and managing matters related to the admission of international students and the administration of scholarships.
31. Clinical Education Committee: Responsible for overseeing and promoting matters related to clinical education at the university and its

affiliated hospitals.

32.Sustainability Development Promotion Committee: Responsible for formulating the university's sustainability goals and strategic directions, the planning and implementing support systems, and the reviewing and monitoring the progress of sustainability initiatives.

33.Digital Education Promotion Committee: Responsible for overseeing and promoting the development of digital education at the university, in order to facilitate diversified learning opportunities for students.

34.Bilingual Education Promotion Committee: Responsible for coordinating and supervising the development and resource allocation for bilingual education with an aim to enhance the university's overall international competitiveness.

Other committees may be established by the university when necessary.

Article XLIII (Title of Staff)

The university's staff includes: special committee members, compilers, specialists, associates, administrators, clerks, senior technicians, technicians, and assistant technicians, all of whom shall be appointed by the President.

The implementation of the university's staffing plan of the university's staff follows their passage and approval by the Board of Trustees and subsequent authorization by the Ministry of Education. The same shall apply with revisions with these Regulations.

Article XLIV (Enactment, Amendment, and Implementation)

The implementation of these plan of these Regulations follows their passage and approval by the Board of Trustees and subsequent authorization by the Ministry of Education. The same shall apply with revisions with these Regulations.
